## LIMITED WARRANTY

## CPS 2000 COALESCENT PHASE SEPARATOR

Products manufactured and sold by Taylor Environmental Products ("Taylor") are warranted by Taylor to be free from defects in material and workmanship under normal use and service when operated at or below rated capacities in accordance with operating instructions.

This warranty is limited to repair or replacement, (as Taylor may elect, and at an establishment authorized by Taylor) of such parts as shall appear to Taylor upon inspection to have been defective in material or workmanship

This warranty period shall begin on the delivery date of the product/system to the purchaser and end twelve months (1 year) from delivery date. During this twelve-month period Taylor will provide parts and labor to replace or repair any part furnished by Taylor and found to be defective in material and workmanship.

## THE FOLLOWING ITEMS ARE NOT COVERED BY THIS WARRANTY:

- The CPS 2000 is designed to separate oil from water and suspended solids from water (sludge).
  Dischargeability of wastewater will depend on the composition of the water itself as determined by a
  wastewater analysis prior to installation of the system. Any change in this wastewater analysis after
  installation may require change in the system itself. Water composition may mandate additional efforts to
  allow dischargeability. Taylor makes no warranty as to dischargeability of water.
- Bacterial oxygen demand (BOD) and chemical oxygen demand (COD) elements identified in the wastewater analysis may require additional modifications of the CPS 2000. Taylor makes no warranty relating to the dischargeability of water as relates to BODs and CODs.
- 3. Normal deterioration of appearance due to use and exposure, or conditions resulting from misuse, negligence, or accident are <u>not</u> covered
- Any products on which any of the required or recommended periodic inspections or services have not been made are <u>not</u> covered.
- 5. Any parts or accessories installed on the product during the warranty period by anyone other than Taylor or Taylor's authorized representatives are **not** covered.
- 6. Loss of time, inconvenience, loss of equipment use, other consequential damages or other matters not specifically included are <u>not</u> covered.
- 7. Fines and penalties imposed by operation of law including but not limited to civil or criminal fines environmental damages or assessments imposed by any agency of the state, local or federal government or incurred by civil liability from any person or entity are <u>not</u> covered.

Taylor parts and assemblies, which are furnished and installed under this warranty, are themselves within the coverage of the machine warranty and are covered only for the duration of the original machine warranty period.

Note: All International warranty parts shipments are F.O.B. point of debarkation, duties, tariffs, and or local taxes excluded.
